2 1 SUPERVISOR MAHAN: Before we begin with personnel 2 and our regular agenda, for those of you who might not be aware and for our viewers, yesterday we had 3 4 announced a renewable energy project. It is a 5 hydro-power and we entered into this agreement. It is a 6 20 year agreement - a power purchase agreement with 7 gravity renewables. It uses an innovative mechanism 8 known as remote net metering and this agreement will 9 substantially underwrite the Town's energy costs 10 through the purchase of locally produced hydroelectric 11 power. Colonie will receive monetary green credits from 12 National Grid. This will help offset 50% of the 13 electric load climate friendly renewable power and it will basically offset 50% of our carbon footprint and 14 15 greatly reduce our energy bills. 16 So, we had a tour of the facility yesterday which 17 is in Schuylerville. It was quite fascinating to see. 18 It's a partnership. Is a great agreement. It is 19 great for the Town and great for our environment and the 20 regional economy, as well. 21 I want to give a special thank you to Doug Sippel 22 who is here tonight. Doug did a tremendous amount of work. Doug did a tremendous amount of work on this 23 agreement. It has been in the works for a couple of 24 25 years. It really came together nicely.

1	3 This is a really good agreement and again this is
2	for 20 years for the Town.
3	Also, I want to thank Jack Spath who is one of our
4	attorneys that worked on this agreement as well. He is
5	not here this evening.
б	Also, Sara Weist from my staff worked on this with
7	us.
8	Yesterday Jack and Doug and Linda and Paul and
9	Sarah took a tour of the facility. It is quite
10	interesting. This is a great thing for the Town and over
11	20 years, it's really going to save us a lot on our
12	energy costs. I just want to announce that for anybody
13	who didn't know of it or didn't read about it.
14	At this point we are going to begin the meeting
15	with personnel.
