1 SUPERVISOR MAHAN: Good evening 2 everybody. We will begin with personnel. 3 MS. GANSLE: We have a Resolution 4 authorizing Kevin Page in the DPW Division of 5 Highway Department to take leave without pay. 6 MS. MURPHY: So moved. 7 MS. PENN: Second. 8 SUPERVISOR MAHAN: Supervisor votes aye. 9 Clerk, call the roll. 10 (The roll was called.) 11 MS. GANSLE: The ayes have it, Madam 12 Supervisor. 1.3 SUPERVISOR MAHAN: The Resolution is 1 4 adopted. MS. GANSLE: We have a Resolution 15 16 authorizing Daniel A Marinucci in the DPW 17 Division of Latham Water to take leave 18 without pay. 19 MS. MURPHY: So moved. 20 MR. GREEN: Second. 21 SUPERVISOR MAHAN: Supervisor votes aye. 2.2 Clerk, call the roll. 23 (The roll was called.) 24 MS. GANSLE: The ayes have it, Madam 25 Supervisor.

1 SUPERVISOR MAHAN: The Resolution is 2 adopted. 3 (Whereas the above entitled proceeding 4 was adjourned to address the public hearings 5 of the evening and recommenced immediately 6 after.) 7 Does anyone have any public comments 8 other than the panhandling or the adjournment 9 of the last public hearing? 10 (There was no response.) 11 Okay, we will go on to regular 12 Resolutions. MS. GANSLE: We have a Resolution 13 1 4 authorizing acceptance of a proposal from 15 Arthur J. Gallagher & Company to provide 16 excess automobile insurance coverage for the 17 Town of Colonie through the Travelers 18 Indemnity Company. 19 MS. JEFFERS VONDOLLEN: The cost of the 20 excess automobile policy for this period is 21 \$105,873. So moved. 2.2 MS. MURPHY: Second. 23 SUPERVISOR MAHAN: Supervisor votes aye. 24 Clerk, call the roll. 25

(The roll was called.)

1 MS. GANSLE: The ayes have it, Madam 2 Supervisor. 3 SUPERVISOR MAHAN: The Resolution is 4 adopted. 5 MS. GANSLE: We have a Resolution 6 authorizing acceptance of a proposal from 7 Arthur J. Gallagher & Company to provide 8 primary automobile insurance coverage for the 9 Town of Colonie through Selective Insurance 10 Company of New York. 1 1 MS. JEFFERS VONDOLLEN: The cost for 12 this renewal policy is \$375,168. So moved. 13 MS. MURPHY: Second. 1 4 SUPERVISOR MAHAN: Supervisor votes aye. 15 Clerk, call the roll. 16 (The roll was called.) MS. GANSLE: The ayes have it, Madam 17 18 Supervisor. 19 SUPERVISOR MAHAN: The Resolution is 20 adopted. 21 MS. GANSLE: We have a Resolution 2.2 authorizing the Supervisor to enter into an 23 Agreement with South Colonie Central School 24 District for the exchange of a Town owned 25 vehicle for a School District owned vehicle.

1 MS. PENN: So moved. 2 MS. JEFFERS VONDOLLEN: Second. 3 SUPERVISOR MAHAN: This is an equal 4 swap. There's no cost to the Town. 5 Supervisor votes aye. Clerk, call the 6 roll. 7 (The roll was called.) 8 MS. GANSLE: The ayes have it, Madam 9 Supervisor. 10 SUPERVISOR MAHAN: The Resolution is 11 adopted. 12 MS. GANSLE: We have a Resolution 1.3 calling a public hearing in regard to the 1 4 proposed rezoning of land located at 44 15 Waterford Avenue East from single family 16 residential to multi-family residential. 17 The public hearing will be MR. GREESON: 1 8 scheduled for September 10, 2020 at 7:00 PM. So moved. 19 20 MS. PENN: Second. SUPERVISOR MAHAN: Supervisor votes aye. 21 2.2 Clerk, call the roll. 23 (The roll was called.) 24 MS. GANSLE: The ayes have it, Madam 25 Supervisor.

SUPERVISOR MAHAN: The Resolution is 1 2 adopted. 3 MS. GANSLE: We have a Resolution requiring the Planning Board to review and 4 5 consider an open development area at 560 6 Boght Road. 7 MS. JEFFERS VONDOLLEN: So moved. 8 MS. MURPHY: Second. 9 SUPERVISOR MAHAN: Supervisor votes aye. 10 Clerk, call the roll. 11 (The roll was called.) 12 MS. GANSLE: The ayes have it, Madam 13 Supervisor. SUPERVISOR MAHAN: The Resolution is 1 4 15 adopted. 16 MS. GANSLE: We have a Resolution 17 authorizing the Supervisor to reimburse for 18 overestimated water usage at 1A Maplewood 19 Avenue. MS. MURPHY: So move. This is at a cost 20 21 of \$8,521.24. 2.2 MR. GREEN: Second. 23 SUPERVISOR MAHAN: Supervisor votes aye. 24 Clerk, call the roll. 25 (The roll was called.)

1 MS. GANSLE: The ayes have it, Madam 2 Supervisor. 3 SUPERVISOR MAHAN: The Resolution is 4 adopted. 5 MS. GANSLE: We have a Resolution 6 awarding the bid to Pollard Excavating in 7 connection with replacing butterfly valves, 8 actuators and couplings at the Mohawk View 9 Water Treatment Plant and authorizing the 10 Supervisor to enter into an agreement for 11 same. 12 MS. MURPHY: This is the low bidder. So 1.3 moved. 1 4 MR. GREEN: Second. 15 SUPERVISOR MAHAN: Supervisor votes aye. 16 Clerk, call the roll. 17 (The roll was called.) MS. GANSLE: The ayes have it, Madam 18 19 Supervisor. 20 SUPERVISOR MAHAN: The Resolution is 21 adopted. 2.2 MS. GANSLE: We have a Resolution 23 authorizing the Supervisor to execute Change 24 Order No. 2 to the contract with New Castle

Paving, LLC in connection with the

Albany/Colonie interconnection project.

MS. MURPHY: This change order is at a cost of \$266,378.28. So moved.

Supervisor votes aye. Clerk, call the roll.

MS. GANSLE: The ayes have it, Madam Supervisor.

SUPERVISOR MAHAN: The Resolution is adopted.

MS. GANSLE: We have a Resolution authorizing the Supervisor to execute an application to the Office of General Services in connection with the federal surplus property program.

MR. GREEN: So moved.

MS. PENN: Second.

JEFFERS VONDOLLEN: So moved. 1 4 MS. MURPHY: Second. 15 SUPERVISOR MAHAN: Supervisor votes aye. 16 Clerk, call the roll. 17 (The roll was called.) MS. GANSLE: The ayes have it, Madam 18 19 Supervisor. 20 SUPERVISOR MAHAN: The Resolution is 21 adopted. 2.2 MS. GANSLE: We have a Resolution authorizing the issuance of revenue 23 24 anticipation notes and renewal notes of the 25 Town of Colonie, Albany County, New York, in

1 an aggregate principal amount not to exceed 2 \$3,500,000. 3 MR. GREEN: This is an annual Resolution that we do every year towards the end of the 4 year to cover some cash flow issues. So 5 6 moved. 7 MS. JEFFERS VONDOLLEN: Second. 8 SUPERVISOR MAHAN: This is also - we do 9 this every year because our fourth quarter 10 tax does not come in until January. We don't 11 get it in December. So, when it comes in 12 January, we immediately pay that off. It's a 13 logistical thing. 1 4 Supervisor votes aye. Clerk, call the roll. 15 (The roll was called.) 16 MS. GANSLE: The ayes have it, Madam 17 Supervisor. 18 SUPERVISOR MAHAN: The Resolution is 19 adopted. 20 That's it for tonight.
