Town of Colonie Local Law No 1 of the year 2017

A local law rezoning 10.655 +/- acres of land located at 59 Pollock Road from an Office Residential district to a Single Family Residential district.

Be it enacted by the Town Board of the Town of Colonie of as follows:

SECTION 1. REZONING

Schedule "B" of Local Law No. 1 of 2007, adopted pursuant to Section 4 of such Local Law, is commonly known as the "Land Use Law" of the Town of Colonie. Chapter 190, Section 17 (A) of such Land Use Law is hereby amended as follows:

The following described area consisting of 10.655 +/- acres of land located at 59 Pollock Road is hereby rezoned from an Office Residential (OR) district to a Single Family Residential (SFR) district:

Beginning at a point in the southerly boundary line of Pollock Road at its point of intersection with the division line between lands on the east now or formerly of Sable Terrace Development Co., Inc. and lands on the west of the herein described parcel; thence running from said point of beginning the following six (6) courses are along the last mentioned division line:

- 1. S25°-03'-40"8 (74.32) feet to a point;
- 2. S39°-26'-20"W (224.40) feet to a point;
- 3. S04°-08'-40"E (236.28) feet to a point;
- 4. S17°-41'-20"W (1007.82) feet to a point;
- 5. S65°-41'-20"W (126.72) feet to a point; and
- 6. N79°-08'-40"W (174.19) feet to a point in the division line between lands on the west now or formerly of Niagara Mohawk Power Corp. and lands on the east of the herein described parcel; thence N02°-09'-32"E along the last mentioned division line (642.28) feet to a point in the aforementioned southerly boundary line of Pollock Road; thence the following five (5) courses are along the last mentioned southerly boundary line:
 - 1. N46°-47'-37"E (120.27) feet to a point;
 - 2. in a northeasterly direction along a curve to the left having a radius of (600.88) feet a central angle of 26°-ll' -34" and an arc length of (274.69) feet to a point;
 - 3. N20°-36'-07"E (185.81) feet to a point;
 - 4. in a northeasterly direction along a curve to the right having a radius of (301.15) feet a central angle of 33°-40'-05" and an arc length of 176.96) feet to a point; and

5. $N56^{\circ}$ -56'45"E (266.76) feet to the point of beginning.

SECTION 2. ZONING MAP

Section 190-17 (A) of the Code of the Town of Colonie is amended by modifying the Town of Colonie Zoning Map described therein to reclassify those lands described in Section 1 above. Said map shall be modified and a copy of the revised map shall be filed with the Town Clerk of the Town of Colonie.

SECTION 3. SEVERABILITY

If any clause, sentence or provision of this local law or the application thereof to any person or circumstance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity thereof shall not affect, impair or invalidate the remainder of the provisions of this local law or the application thereof to other persons and circumstances.

SECTION 4. EFFECTIVE DATE

This local law shall take effect upon its proper filing in the Office of the Secretary of State.
