Town of Colonie Local Law No 9 of the year 2017

A local law amending Chapter 79 of the Code of the Town of Colonie, entitled "Dogs and Other Animals"

Be it enacted by the Town Board of the Town of Colonie of as follows:

SECTION 1. ENFORCEMENT OF CURBING OF DOGS

Section 79-14.4 is hereby amended to read as follows:

Enforcement by Animal Control Officers and Police Department.

This article shall be enforced by the Town of Colonie Animal Control Officers and Police Department. In addition, any Animal Control Officer or any peace officer authorized by the Town of Colonie to assist in the enforcement of this article may serve any process related to any proceeding, whether criminal or civil in nature and including an appearance ticket.

SECTION 2. PENALTIES FOR VIOLATION

Section 79-14.5 is hereby amended to read as follows:

Penalties of offenses.

A violation of this Article shall be punishable by a fine of not more than \$150.

SECTION 3. SEVERABILITY

If any clause, sentence or provision of this local law or the application thereof to any person or circumstance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity thereof shall not affect, impair or invalidate the remainder of the provisions of this local law or the application thereof to other persons and circumstances.

SECTION 4. SEQR DETERMINATION.

The Town hereby determines that the adoption of this amendment, which provides for Animal Control Officers and the Police Department to enforce the curbing of dogs provisions in the Code of the Town of Colonie and updates the penalties for violations, is an unlisted action that will not have a significant effect on the environment and, therefore, no other determination or procedure under the State Environmental Quality Review Act ("SEQRA") is required.

SECTION 5. EFFECTIVE DATE

This local law shall take effect immediately upon its filing in the Office of the Secretary of State.
