A local law amending Local Law 2 of 2009, which rezoned 196.74± acres of land at 1035 Loudon Road and 418 Boght Road to a Planned Development District (PDD) (also known as Canterbury Crossing PDD), by revising the plans to include an open pavilion at the Boght Community Fire Department at 8 Preston Drive.

Be it enacted by the Town Board of the Town of Colonie as follows:

SECTION 1. AMENDMENT
