# Town of Colonie Local Law No 4 of the year 2021

A local law amending Local Law No. 11 for 2015 providing for the development of 5.57+/-acres of land within the boundaries of the said 12.37 +/- acres of land comprising the Elks Lane Planned Development District located at 11 Elks Lane to allow for the demolition of an existing building and sheds on the said 5.57+/- acre parcel of land and approve construction of a new 127,500 square foot three story building containing 99 senior apartments, with 162 beds, a senior center, a wellness center and common areas.

# Be it enacted by the Town Board of the Town of Colonie of as follows:

#### **SECTION 1. AMENDMENT**

The following described area consisting of 12.37 +/- acres of land located at 11 Elks Lane was previously rezoned from a Single Family Residential (SFR) district to a Planned Development District (PDD) on or about September 17, 2015:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Colonie, County of Albany, and State of New York more particularly described as follows and as depicted upon the map attached hereto:

BEGINNING at a point of bend in the east line of the lands of the Colonie Elks Lodge;

THENCE South 16°20'55" West along the division line between the lands Colonie Elks Lodge to the West and the lands now or formerly of Schuyler Meadows Golf Club to the East a distance of 475.21 feet to a point;

THENCE through the lands now or formerly of Colonie Elks Lodge the following two (2) courses and distances;

- 1. North 73 ° 40'36" West a distance of 550.67 feet to a point;
- 2. North 49 ° 27'54" West a distance of 140.08 feet to a point in the west line of the lands of Colonie Elks Lodge;

THENCE along the west line of the lands now or formerly of Colonie Elks Lodge the following two (2) courses and distances;

- 1. North 40 ° 31'57" East a distance of 753.19 feet to a point;
- 2. North 28 ° 13'21" East a distance of 392.18 feet to a point;

THENCE through the lands now or formerly of Colonie Elks Lodge South 67 ° 45'34" East 359.66 feet to a point;

THENCE South 22 ° 42'00" West along the division line between the lands of Colonie Elks Lodge to the West and the lands now or formerly of Schuyler Meadows Golf Club to the East a distance of 619.70 feet to the POINT AND PLACE OF BEGINNING.

The proposed subject of this amendment to Local Law No. 11 for 2015 consists of 5.57+/- acres of land located wholly within the above described parcel of land, and more particularly described in Exhibit "A" annexed hereto and made a part hereof.

## SECTION 2. ZONING MAP

Section 190-17 (A) of the Code of the Town of Colonie is amended to provide for the demolition of an existing building and sheds within the said 5.57+/- acre parcel of land and approve construction of a new 127,500 square foot three story building containing 99 senior apartments, with 162 beds, a senior center, a wellness center, common areas, sidewalks and utilities. Said map shall be modified and a copy of the revised map shall be filed with the Town Clerk of the Town of Colonie.

#### **SECTION 3. CONDITIONS**

The subject parcel described in Section 1 above is amended upon the condition that it shall be developed as approved, to wit: construction of a new 127,500 square foot three story building containing 99 senior apartments, with 162 beds, a senior center, a wellness center and common areas, all as more fully detailed in the narrative description, plans, and additional materials provided with the request for the amendment and filed in the office of the Town Clerk. This rezoning is also subject to the terms and conditions of the Planning Board as set forth in the Written Findings of said Planning Board dated September 21, 2021, together with any express conditions of the Town Board filed with the office of the Town Clerk.

#### SECTION 4. SEVERABILITY

If any clause, sentence or provision of this local law or the application thereof to any person or circumstance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity thereof shall not affect, impair or invalidate the remainder of the provisions of this local law or the application thereof to other persons and circumstances.
