1 MS. GANSLE: This public hearing is being held
2 by order of the Town Board to hear all persons in
3 relation to contracting with the Fuller Road, Shaker
4 Road/Loudonville, Maplewood Fire Departments and the
5 S.W. Pitts Hose Company of Latham for fire protection
6 within their particular fire protection districts.

7 Notice of the public hearings has been
8 published in the official Town newspaper which is the
9 Spotlight and has been posted on the Town Clerk's
10 bulletin board. I have an affidavit for each. The Town
11 Board will now hear all persons interested in these
12 proposals.

13 MR. MAGGILLI: This and the following three
14 Resolutions are all the same. The only difference is the
15 fire protection districts that we are dealing with.

16 What these Resolutions do and what this
17 public hearing is for is to authorize the Town to
18 enter into a contract, in this case with the Fuller
19 Road Fire Department. The importance of these
20 contracts is that they form the basis of the fire
21 districts tax levy and its respective district. That
22 is something that is done in the fire district itself
23 with no input by the Town. That's what this public
24 hearing is for.

25 If there are members of the public that would

1 like to speak to this with respect to the fire
2 protection provided by the Fuller Road fire
3 department, now is your chance.

4 SUPERVISOR MAHAN: This is something that we do
5 every time it's needed. The Board has a good
6 understanding of this.

7 Does anyone in the audience have any
8 questions?

9 (There was no response.)

10 We will close the public hearing.

11 MS. GANSLE: We have a Resolution authorizing a
12 contract with the Fuller Road Fire Department Inc. for
13 fire protection within the Fuller Road fire protection
