A public hearing was held on the application of **AJ Signs (Agent for Frank Adams Jewelers)** for the premises located at **144 Wolf Rd.** Carly Clark with AJ Signs made a presentation to the Board. Mary Magguilli made a motion to approve the three wall signs and one freestanding sign as presented. John Casey seconded the motion and the signs were unanimously approved.

A public hearing was held on the application of **Saxton Sign Corp. (Agent for Walmart)** for the premises located at **800 Loudon Rd.** Darren Katz with Saxton Sign Corp. made a presentation to the Board. Bradley Roy made a motion to approve the five wall signs as presented. John Casey seconded the motion and the signs were unanimously approved.

A public hearing was held on the application of **Saxton Sign Corp. (Agent for Taco Bell)** for the premises located at **676 Loudon Rd.** Darren Katz with Saxton Sign Corp. made a presentation to the Board. John Casey made a motion to approve all seven directional signs and two wall signs with the exception of one wall sign conditionally approved. Mary Magguilli seconded the motion and the signs were approved and conditionally approved.

A public hearing was held on the application of **Ray Sign Inc. (ADD Development)** for the premises located at **950 Loudon Rd.** No one made a presentation to the Board. The Sign Review Board reviewed on their own and voted. Mary Magguilli made a motion to approve the wall sign as presented. John Casey seconded the motion and the sign was unanimously approved.
